TO: MEMBERS OF THE MASSACHUSETTS PROPERTY INSURANCE UNDERWRITING ASSOCIATION

RE: CREDIT PROGRAM PURSUANT TO CHAPTER 93 OF THE ACTS OF 1996

Beginning in 1996, General Laws, Chapter 175C, Section 4 was amended to establish a system of credits against assessments levied by MPIUA. As required by statute, the credit program was further amended, effective January 1, 1999, utilizing homeowners' premium written in **Postal Zip Codes**, instead of territories. The credits are a weighted writing credit and a fixed take-out credit for those companies which write homeowners insurance in credit eligible zip codes designated by the Association. The Commissioner of Insurance has approved the credit eligible zip codes listed below.

For calendar year 2020, premiums written in the designated **Zip Codes** by your company in accordance with the terms of the Credit Program will be eligible for credit if written, during the period **January 1, 2020 to December 31, 2020** and reported to the Association in conjunction with your 2021 Insurer's Report. **Do not submit any data at this time**. Please be advised that when the Association solicits credit data, the **risk location, to include street address and city/town,** and **zip code** will be required fields.

The following **Zip Codes** are eligible for writing credits and have been assigned the following weights for calendar year **2020** credit eligible premiums:
